Code of Ethics

All Members of the Beaver Valley Contractors and Suppliers Association shall agree to observe and be bound by the following Code of Ethics:

- e) Members shall comply with rules and regulations prescribed by law and government agencies for the health, safety, and progress of the community.

- g) Members shall deal fairly with their employees, subcontractors and suppliers.
- h) As members of a progressive industry, we encourage research to develop new materials, new building techniques, new building equipment and improved methods of home financing, to the end that every home purchaser may get the greatest value possible for every dollar.
- i) All sound legislative proposals affecting our industry and the people we serve shall have our informed and vigorous support.
- j) We hold inviolate the free enterprise system and the American Way of Life.
- k) We pledge our support to our associates, our local, state, and national associations and all related industries concerned with the preservation of legitimate rights and freedoms.
